URGENT MEETING REQUEST FOR INFORMATION REGARDING THE DISTRIBUTION PROCESS AND RESULTS OF THE MUNICIPAL FISCAL RELIEF FUND

Dear Executive Director:

We refer to the Special Memorandum No. 005-2025 issued by the Office of Management and Budget (OGP, by its Spanish acronym) as well as the letter submitted by OGP to the Fiscal Oversight and Management Board (FOMB) on June 8, 2025, regarding the distribution of funds under the Municipal Fiscal Relief Fund program to be disbursed to various municipalities for liquidity relief, currently under the custody of the OGP.

Respectfully, we request detailed information regarding the evaluation process approved by the FOMB and design by OGP to determine the final allocation of funds to the municipalities.

Specifically, we request that FOMB provides:

- 1. The methodology used to apply the evaluation criteria described in the referenced letter;
- 2. The formula or weighting system used by OGP to allocate the funds among municipalities;
- 3. The specific results of the analysis applied to each municipality, including the values assigned to each of the evaluation criteria;
- 4. The individual score or result of the evaluation process corresponding to each municipality, including both those selected and not selected for distribution.

In accordance with principles of governmental transparency, this information is essential to assess the reasonableness of the distribution of funds from the aforementioned program.

Therefore, we respectfully request that the information be provided and that an urgent meeting be granted, so that we may obtain clarity on the basis of said distribution.
